

1. IDENTIFICATION OF THE CONTROLLER AND GENERAL INFORMATION

Company **UPDN ONE, s.r.o.**, with its registered office at Na strži 1702/65, Nusle, 140 00 Praha 4,, the Czech Republic, Reg. No.: 02 654 962, registered under file number C 221822 by the City Court in Prague (hereinafter referred to as the "**Controller**"), uses cookies on its website www.wexopay.com (hereinafter referred to as the "**website**").

Cookies are small text files, which, by order of the Website, can be stored by the browser in your device when you are visiting the Website. They serve to secure the functionality of some elements of the Website or, for instance, to enable websites to better record website traffic.

2. TYPES OF COOKIES ON THE WEBSITE

On its Website, the Controller uses the following types of cookies, by means of standard solutions, especially from Google, LLC:

- **functional (necessary) cookies**, which serve to secure the basic functionality of some elements and functions of the Website, and if they are not used by the Controller, some functions of the Website would not be displayed correctly,
- **analytical cookies**, which serve to measure the Website traffic and your activity on the Website,
- **marketing cookies**, which serve to target the on-line advertising according to your preferences in the on-line environment.

In accordance with applicable legislation, the Controller is entitled to store the functional (necessary) types of cookies in your device even without your consent. **You can disable the use of the functional cookies in the settings of your browser.** In such a case, however, some functions of the Website will not be displayed correctly.

Other types of cookies (analytical and marketing ones) **are stored by the Controller in your device only if you grant your consent to their use by means of a cookie banner, located at the bottom of the Website. If you do not grant the Controller consent to store the analytical or marketing cookies, the Controller will store in your device only the functional (necessary) types of cookies.**

You can withdraw or change your consent to the storage of cookies in your device any time. You can do so in the settings of cookies, in the cookie banner located at the bottom of the Website.
